

RESOLUTION NO. 4423

A RESOLUTION OF INTENTION OF THE CITY COUNCIL OF THE CITY OF REEDLEY, CALIFORNIA TO ORDER THE FORMATION OF LANDSCAPING AND LIGHTING MAINTENANCE ASSESSMENT DISTRICT NO.1

The City Council of the City of Reedley resolves:

1. The City Council intends to order the formation of an assessment district and to levy and collect assessments pursuant to the Landscaping and Lighting Act of 1972.
2. The improvements to be made in this assessment district are generally described as follows: Improvements to be maintained are street side and median strip landscaping located within each district.
3. This assessment district shall be known as Landscape Maintenance Assessment District No. I, City of Reedley, Fresno County, California. The general location of the assessment district is "City of Reedley Landscape and Lighting Maintenance Assessment District No. 1" and the general location of the district is tentative subdivision maps of Tract 4131, 4143, and 4222 in the City of Reedley, County of Fresno, State of California, consisting of single family residential lots and Edgewater Inn Development known as a portion of APN 365-070-21.
4. In accordance with the City Council's resolution initiating proceedings, the City Engineer has filed with the City Clerk the report required by the Landscaping and Lighting Act of 1972. All interested persons are referred to that report for a full and detailed description of the improvements, the boundaries of the assessment district and the proposed assessments upon assessable lots and parcels of land within the assessment

district.

5. On Tuesday, the 23rd day of April, 1991, at the hour of 7:30 p.m., the City Council will conduct a public hearing on the formation of this assessment district and the levy of the proposed assessment. The hearing will be held at the meeting place of the City Council located at the City Hall, 845 "G" Street, Reedley, California.

6. The City Clerk is authorized and directed to give the notice of hearing required by the Landscaping and Lighting Act of 1972.




